

## 2021-22 International Student Certification of Finances

You are responsible for demonstrating you have sufficient funds to meet all educational and personal expenses for the duration of your F-1 status at Central College in Pella, lowa before Central College can issue a certificate of Visa Eligibility Form I-20. This means you must officially prove you have the amount necessary to cover your tuition, fees, living and personal expenses for your first academic year (fall and spring semesters), AND sufficient and dependable resources to cover each additional year.

Official proof of funding cannot be more than three months old at the time of application.
